'BLOCK VOTE' ELECTIONS 2022/23 Results

Results of Revenue and Customs Block Vote elections

In the course of this year's 'Block Vote' elections, and in accordance with the Regulation 7 of the Block Vote Election Regulations, at the closing date for nominations (10 March 2022), where there were the same number or fewer nominees than available positions, those nominees were elected unopposed.

Under those same Regulations, where there are still vacancies, a further round of nominations are called for at Group Conference, with a view to filling those vacancies. Consequently, a number of candidates were nominated at Group Conference and a ballot was arranged.

Issues had first begun to arise when, following the announcement of the number of vacancies, it transpired that a sitting member of one of the Block Vote committees had resigned without the Group Office being informed, meaning that the number of seats to be elected, along with the number of residual seats to be filled on that committee, was greater than previously advertised.

There were then a number of problems with the production of Block Vote ballot papers at Group Conference, including technical problems in the production of the papers, and some nominees who had already been elected appearing on the ballot paper for the residual positions. Another issue was that it transpired that the Conference-based election for the residual posts had not registered that one of the candidates for one of the positions had been elected unopposed in the earlier tranche of nominations, and so an additional vacancy was sought unnecessarily.

There were also delays in the analysis of the Block Vote results, due to the knock-on effect of the re-run GEC Election and given that a number of candidates in the Block Vote Elections had also stood for GEC positions. Members of the GEC cannot also sit on committees whose role is to advise the GEC of which they are a member, so this means that some candidates had to be subsequently declared 'not elected' in the Block Vote Elections, despite receiving a higher number of votes than other candidates in the election at Group Conference.

Following the initial round of nominations, the nominations called for during Group Conference 2022, and the exclusion of newly-elected GEC members from elected Block Vote positions; the final results for the

various Block Vote elections, showing those elected unopposed following the initial nomination process, and those elected at Group Conference (along with number of votes cast) are as follows:
